Projects:

Village Hall car parking area – funding required

Due to a lack of interest, the Speedwatch team has been disbanded and equipment returned.

The Ashwicken Lakes project appears to be defeated but we need to be mindful moving forward in case it reappears.

The Sailing Club area requires urgent work as now looking derelict.

Concerns on the Local Plan as it was suspended by the examiners and wording changes have taken place but no underline work.

The National Planning Policy changes are due in November 2023.
The Town Fund projects are running behind and there could be some re-thinking for the new administration of the Borough Council. The issues at Leziate & Ashwicken are very much a part of my business and I hope to have more clout now.
